

8 - The classes, or regional or other groups, of members that the corporation is authorized to establish

The Corporation is authorized to establish one class of Members. Each Member shall be entitled to receive notice of, attend and vote at all meetings of Members of the Corporation.

9 - Statement regarding the distribution of property remaining on liquidation

Any property remaining on liquidation of the Corporation, after discharge of liabilities, shall be distributed or disposed of to one or more charities in Canada that are registered as such under the Income Tax Act (Canada) or equivalent designation under such legislation, and have similar charitable purposes and a similar statement of faith to that of the Corporation at the time of liquidation.

10 - Additional provisions, if any

- (1) The Corporation shall be carried on without the purpose of gain for its Members, and any profits or other accretions to the Corporation shall be used in furtherance of its purposes.
- (2) Directors shall serve without remuneration, and no Director shall directly or indirectly receive any profit from his or her position as such, provided that a Director may be reimbursed for reasonable expenses incurred in performing his or her duties.
- (3) Any By-law, amendment or repeal of a By-law shall require confirmation by a majority of directors and sanctioned by an affirmative vote of at least two-thirds (2/3) of the voting members at a meeting called for such purpose.

6. Statement of the purpose of the corporation

The purposes of the Corporation are:

- To receive and accept donations, contributions and gifts of any and every kind in each or whatsoever whether by way of free will offerings, bequests, devises, gifts, contributions and gifts for the accomplishing in trying out of the purposes of the Corporation.
