MINISTRIES INCLUDE YOUTH OUTREACH AND CONFERENCES, LEADERSHIP TRAINING, FRIENDSHIP EVANGELISM, BIBLE STUDIES, WORSHIP SERVICES, AND OTHER CHURCH-RELATED ACTIVITIES.

EVANGELISM AND DISCIPLESHIP - ALASKA - THE ORGANIZATION PROVIDES FUNDING AND ADMINISTRATIVE SUPPORT FOR OVER 10 MISSIONARY FAMILIES WHO PROVIDE EVANGELIZATION AND DISCIPLESHIP IN APPROXIMATELY 5 COMMUNITIES IN ALASKA. HOME MINISTRY, BIBLE SCHOOLS, AND OTHER MINISTRIES - IN ADDITION TO SERVING IN CANADA, ALASKA, AND RUSSIA, THE ORGANIZATION'S STAFF ALSO MINISTERS TO CHURCHES AND INDIVIDUALS IN THE 48 CONTIGUOUS STATES IN RETURN FOR PROGRAM FUNDING. FIELD STAFF SPEAK AND TEACH IN THESE SUPPORTING CHURCHES ON A REGULAR BASIS.

THE ORGANIZATION ALSO OPERATES EXTENSION BIBLE TRAINING AND DISCIPLESHIP PROGRAMS, AS WELL AS FOLLOW-UP MINISTRY TO FORMER STUDENTS.

FROM TIME TO TIME, WHEN THE ORGANIZATION'S MINISTRY PURPOSES CAN BE EXPANDED, STAFF WILL BE ASSIGNED TO MINISTER WITH OTHER ORGANIZATIONS ON A SHORT-TERM BASIS.
