Infrastructure and Administration

Onboarding New Staff

We have held workshops in January, April and in July. All of our appointees have had some field equipping, and we continue to work our way through these workshops.

A Novel Approach

A Novel Approach was to be introduced during our annual conference in May. We will begin the first stage of this process in August, and look forward to the following steps toward utilization of ministry at this level of understanding.

Biblical Counseling

We look forward to working with Twelve Stones' Counseling to eventually run a training course at the Lazy Mountain Campus.
